 - **Analysis on sustainability standards such as ISSB and other regulations**
 - Purpose: to assess your information gathering and presentation skills
 - **Financial analysis on one listed company (pre-assigned)**
 - Purpose: to assess financial modelling in Excel and financial accounting skills (to test understanding of three financial statements)
- I would like to gauge your interest in Green Finance. Advanced knowledge is not required

Academic Background:

- Any academic backgrounds or majors are welcome
- Students who are keen to learn about green finance business, analysis of sustainability

- reports, climate-related standards, and green finance regulations
- Students who have the capabilities to analyze the details of financial statements, financial schemes, sustainability standards, business models, and government regulations; and to create corresponding delivery materials
 - Students who have data analytics skills for gathering and analyzing open-source data
